

## SHRI FULAN SINGH NATIONAL SCHOLAR OLYMPIAD RESULT 2024

## Criteria for scholarship

- 1. In the FSCET 2024 exam total number of questions will be 100. Each will be carrying 1 mark. There will be no negative marking.
- 2. FSCET 2024 question paper will include questions from basic subject knowledge (up to 12<sup>th</sup> level for UG and undergraduate level for PG), language (English) current affairs, and general studies.
- 3. 50% marks will be the qualifying criteria in FSCET 2024. The candidates securing 50% and above marks will only be considered for scholarship.
- 4. FSCET 2024 result is only valid for academic session 2024-25 for admission in first semester of undergraduate and postgraduate program. Initially, this scholarship will be applicable for the 1<sup>st</sup> year and continuation of the scholarship will be on the following criteria:-
  - Candidate must have minimum 80% attendance throughout the year.
  - SGPA/CGPA should not be less than 7.5.
  - The candidates should not have any carry over paper. If a candidate has a carry over, their scholarship will be cancelled and they will have to pay full fees accordingly in subsequent years.
- 5. This scholarship is applicable for non-council courses only.
- 6. University reserves the right to grant or cancel the scholarship without prior notice. The university's decision will be considered final and no claims will be entertained for the same.
- 7. The results posted on the official website of FS University are deemed final, and no queries or appeals regarding the results will be entertained. In the rare event of any dispute arising in relation to the FSCET 2024, the ultimate decision will be rendered by FSCET 2024 Committee, FS University, and it will be acknowledged as conclusive by all parties involved. Furthermore, it's noteworthy that FS University retains the right to revoke the candidature of any student without explanation, and no communication regarding this action will be entertained. Additionally, FS University also reserves the right to cancel the FSCET 2024 without the need to furnish a specific reason, and, in such a circumstance, no communication will be entertained.

**NOTE** - Admission through FSCET 2024 with a scholarship is only valid till **July 20, 2024**. After this, no admission will be given with a scholarship on the FSCET 2024 score
